The CEO provided a verbal update of recent meetings and events.

- B. Gorman and J. Rocca recently attended the Town's Finance Advisory Committee (FAC) meeting, providing an in depth review of the Library's budget. Thank you to A. Mobbs and L. Hanna for attending on behalf of the Library Board and to Councillor R. Weese for his work on the Town's FAC.
- B. Gorman was invited to attend an Aurora Town Square (ATS) donor recognition event.

Collective Bargaining with the Library's CUPE 905.02 employee group continues. The Board will be updated throughout the process.

- B. Gorman attended an Association of Medium-sized Public Libraries Ontario (AMPLO) meeting to share best practices and connect on key issues facing similar libraries.
- B. Gorman followed up on concerns expressed at the Library Board's May meeting about assisted parking. Currently, there are two (2) assisted parking spaces reserved in the plaza north of the Library on Yonge Street. The Town will ensure tenants of the plaza are aware that these are designated spaces. There are four (4) designated parking spaces on Victoria Street for ATS and three (3) spaces on Church Street. There will be two (2) spaces near our entrance and five (5) additional spaces in the parking lot when it opens to the public.

The Library is once again working with York Region as a designated warming and cooling centre. During the current heat advisory, APL is posting through our social media channels that the Library spaces are available for individuals looking for relief from the heat.

Once again, the Library is a destination for high school students during exam time. On June 18<sup>th</sup>, a new single day record was set with 2322 in person visitors to our spaces.
